

**2026 School District Meeting Minutes**  
**March 9, 2026**

The Landaff School District held their annual meeting on Monday, March 9, 2026. The District Moderator, Judith Boulet, announced the commencement of the 2026 School District Meeting at 7:02pm.

The Moderator introduced the school board - John Barth, Matt Copithorne and Michelle Beaudin, as well as Superintendent CJ Watson, Business Manager Toni Butterfield, Head Teacher Kolonie Hudson and District Clerk Sara Campbell. She then reviewed the rules of the meeting.

Article 01: To hear the reports of Agents, Committees, or Officers heretofore chosen and pass any vote relating thereto.  
**Motion by Rachel Booth to bring forward and accept Article 01 as written.**  
**Motion seconded by Harry McGovern. Voice vote in affirmative. Article 01 passes.**

Article 02: To see if the Landaff School District will vote to raise and appropriate the amount of the sum of One Million, Seven Thousand, Seven Hundred Seventy-Eight Dollars (\$1,007,778.00) for the support of schools, for the payment of salaries for the school district officials and agents, and for the payment for the statutory obligations of the district. This article does not include appropriations contained in special or individual articles addressed separately. (Majority vote required) (recommended by the Landaff School Board)  
**Motion by Erroll Peters to bring forward and accept Article 02 as written.**  
**Motion seconded by Deb Erb.**

Discussion: Deb Erb asked if the school board report in the town report was discussed at the last meeting, as she did not attend. Matt Copithorne confirmed it was discussed, and gave a recap that the board recommended the Blue School close beginning with the 2026/2027 school year, and the budget in Article 2 reflects this recommendation.

**Voice vote in affirmative. Article 02 passes.**

Article 03: To see if the school district will vote to raise and appropriate the sum of \$40,000 to be added to the Building Maintenance Capital Reserve Fund established in March, 2005. This sum to come from June 30 fund balance available for transfer on July 1. No amount to be raised from taxation. (Majority vote required) (Recommended by the Landaff School Board)  
**Motion by Joe Wiggett to bring forward and accept Article 03 as written.**  
**Motion seconded by Don Beaudin.**

Discussion: Erroll Peters questioned needing as much as \$40,000.

**Motion by Michael Ransmaier to amend Article 3 to raise and appropriate the sum of \$20,000 to be added to the building Maintenance Capital Reserve Fund instead of \$40,000.**

**Motion to amend seconded by Tracey Upton**

**Hand vote taken to amend Article 3:**
