Tuition agreement discussion with Lisbon School Board Chair: Lisbon school board member, Arthur Boutin, presented a proposed tuition rate for grades 4-8 of \$17,000.00 per student and grades 9-12 of \$19,000.00 per student but will decrease that rate by \$1,000.00 per student if Landaff sends at least 80% of their students to Lisbon for the next year; a discussion ensued.
- 2. 25-26 SY Budget: Matt presented the budget which is in flux with a 7.5% increase which is down some from last year and discussed the capital reserve funds; a discussion ensued; regular education tuition is up 15%; special education is down 35%; preschool is up 72%; speech is up 27%; PT and OT are up 10%; the SAU cost is up 38%; a discussion ensued. There is a beginning balance of \$50,000.00; adequacy is down 40%. A discussion ensued.
